

AGREEMENT AND RELEASE OF ALL LIABILITY

I voluntarily accept all risk relating to but not limited to personal injury (including death), and property damage arising from my attendance and participation in this event.

I, the undersigned, in consideration of accepting this entry, do hereby for myself, my heirs, executors, and administrators, forever waive and release the Davenport Dare Endurance Ride, its sponsors, and all individual members thereof and all other persons regardless of their capacity in any way connected with the event described herein, their representatives, heirs, executors, administrators and assigns, as well as property owners over whose property the trail passes, from any and all right, claim or liability for damages, or for any and all claims of any kind and nature that I might have. Further, I do hereby acknowledge that said release will extend to any accidents, damages, or claims arising out of my entry caused by my own act or the acts of anyone in my party or crew, or any animal within my control. I do further acknowledge that I have carefully read the forgoing and fully agree with and understand the contents herein. I understand that the forgoing is a complete release of liability and a promise not to sue or make a claim. I am aware that this is a contract between myself and the Davenport Dare Endurance Ride.
